ASA Airline Representative

AMFA Local 14 is accepting nominations for the position of **ASA Airline Representative**.

The Airline Representative serves a term of **two years**. His/her duties are described in Article XVIII, Section 3 of the AMFA Constitution and Article III, Section 2 G of the Local 14 Bylaws.

Qualifications for the position of Airline Representative are detailed in the AMFA Constitution, Article XVIII, Section 3 C as follows:

Qualifications for this position shall be a member in good standing, free from delinquency of any nature to the Local or National Association, who has attended **fifty percent (50%) of all regularly scheduled membership meetings** held during the **two years** preceding nomination. Meetings that a member is unable to attend because of verified illness, death in the immediate family, vacation, official Association business, jury duty, service in the armed forces of the United States, or because they **reside and work beyond a fifty mile radius of where the meeting is held** will not be counted in determining such member's eligibility under this section.
